Pursuant to Article 57 paragraph 2 of the Law on Tourism Activity ("Official Gazette of the Republic of Macedonia" No. 62/04, 89/08, 12/09, 17/11, 47/11, 53/11, 123/12, 164/13, 27/14,

116/15 and 192/15), the Minister of Economy adopted

**RULEBOOK AMENDING THE RULEBOOK
ON THE MANNER, TYPE, AND THE AMOUNT OF THE SUBSIDIES**

Article 1

The Rulebook on the manner, type and amount of subsidies ("Official Gazette of the Republic of Macedonia" No. 53/13, 147/14 and 50/15) in Article 9 paragraph (2) shall be modified and it shall read:

"The amount of the subsidy per arrived foreign tourist is:

- a) from European destinations, except for the Benelux countries, Finland, Norway, Denmark, Sweden, England, Germany, Russia, Ukraine, Israel, Austria, Italy, France, Spain, the Czech Republic, Slovakia, Hungary, Poland and Romania, 25 Euros in Denar equivalent;
- b) for the Benelux countries (Belgium, Netherlands, Luxembourg), Finland, Norway, Denmark, Sweden, Russia, Ukraine, United Arab Emirates, China, India, Germany, England, Kazakhstan, Azerbaijan, Qatar, the United States of America, Japan, Israel, Austria, Malaysia, South Korea, Italy, France and Spain, 65 Euros in Denar equivalent;
- c) for the Czech Republic, Slovakia, Hungary, Poland and Romania, 35 Euros in Denar equivalent and
- d) from intercontinental destinations, 45 Euros in Denar equivalent "

Paragraph (3) shall be modified and it shall read:

"The amount of the subsidy per arrived foreign tourist from Bosnia and Herzegovina, Serbia, Albania, Kosovo and Bulgaria, with a minimum of four overnights with breakfast, shall be 35 Euros in Denar equivalent".

Article 2

In Article 10, paragraph (2) after the word "Japan", the words: "Israel, Austria, Malaysia, South Korea, Italy, France and Spain" shall be added.

After paragraph (2), a new paragraph (3) shall be added which reads as follows:

"(3) Notwithstanding paragraph (1) of this Article, the amount of the subsidy per arrived foreign tourist from the Czech Republic, Slovakia, Hungary, Poland and Romania, with a minimum of three overnights with breakfast, shall be 35 Euros in Denar equivalent".

In paragraph (3), which becomes paragraph (4), the word "seven" shall be replaced by the word "four". Paragraphs (4), (5), (6), (7), (8), and (9) become paragraphs (5), (6), (7), (8), (9) and (10).

Article 3

This Rulebook shall enter into force on the day following its publication in the "Official Gazette of the Republic of Macedonia".
