# RULEBOOK ON THE MODIFICATIONS AND AMENDMENTS OF THE RULEBOOK FOR THE MANNER, TYPE AND AMOUNT OF SUBSIDIES

#### Article 1

In the Rulebook for the manner, type and amount of the subsidies ("Official Gazette of the Republic of Macedonia", no. 53/13 and 147/14), in Article 3 paragraph (1) line 1 is hereby modified and reads:

"-Stay in Macedonia with realized at least three overnight stays with breakfast, in accommodation capacities which have valid decision for categorization (hereinafter referred to as: categorized accommodation capacities);".

#### Article 2

In Article 5 paragraph (1) line 3 is hereby modified and reads: "-Copy of the lease contract with the categorized accommodation capacity, concluded before or at the moment of commencement of the stay of foreign tourists and a copy of the decision for categorization, with a validity for the period of accommodation of the group;".

## Article 3

In Article 9 paragraph (2) in item a) after the word "Sweden", the following words are added: "UK, Germany".

In item b) after the words "United Arab Emirates", the following words are added "China, India, Germany, UK, Kazakhstan, Azerbaijan, Qatar, United States of America. "

After paragraph (2) a new paragraph (3) is added and reads: "(3) The amount of subsidy per arrived foreign tourist from Bosnia and Herzegovina, Serbia and Bulgaria, with realized minimum seven overnight stays with breakfast, is 35 EUR in MKD counter-value."

#### Article 4

In Article 10 in paragraph (2) after the words "United Arab Emirates", the following words are added – "China, India, Germany, UK, Kazakhstan, Azerbaijan, Qatar, United States of America. "

In paragraph (2) a new paragraph (3) is added which reads: "(3) Upon the exception from paragraph (1) of this Article, the amount of the subsidy per arrived foreign tourist from Bosnia and Herzegovina, Serbia and Bulgaria, with realized minimum seven overnight stays with breakfast, is 35 EUR in MKD counter-value."

Paragraphs (3), (4), (5), (6), (7) and (8) become paragraphs (4), (5), (6), (7), (8) and (9).
